#### AMERICAN FARMLAND TRUST - \$1.6 M MICROGRANT

American Farmland Trust (AFT, http://farmland.org/) has partnered with Tillamook Creamery (https://www.tillamook.com/) to launch the Brighter Future Microgrants Program. I am reaching out to you with information about the upcoming microgrant opportunity for farmers within a Philadelphia area Tillamook-distribution radius. The Brighter Future Microgrant Program seeks to support farmers in successfully launching, growing, or sustaining their farms in the face of many current challenges. The COVID-19 pandemic, changing markets, climate change, natural disasters, and other forces are impacting the U.S. food and agricultural system. Brighter Future Microgrants will be awarded in amounts between \$1,000-5,000. The Microgrants can be applied towards equipment/infrastructure (that promotes conservation practices) or professional services (such as hiring a lawyer to develop a farm lease, or a service provider to create a business plan.) Specifically, AFT has committed that at least 50% of microgrant funds will be awarded to BIPOC and LGBTQ+ farmers. There will also be a focus on supporting female-identifying farmers. Applications will be reviewed on a first-come, first-served basis and there is limited funding, which is why I am reaching out to you about this opportunity. Could you please share with farmers in your community that could benefit from this program? One of AFT's goals is for the microgrants to complement regionally based organizations' existing work and be of benefit for the farmers with whom they are working. Your Philadelphia area organization may work with traditionally underserved farmers or their valuable contributions to the local food system. Please encourage farmers you know to submit early applications to this microgrant program. More information can be found here: https://farmland.org/brighter-future/.

#### THINK SPRING! - ORDER SHRUBS AND TREES

Orders are now being accepted for the spring 2021 planting season for shrubs and trees from the John S. Ayton State Tree Nursery, managed by the Maryland Department of Natural Resources. Trees benefit the environment as well as enhance natural habitat for birds, squirrels and other wildlife. Almost all trees and shrubs available for sale are native, and many are also pollinator-friendly. The best time to plant bareroot seedlings in Maryland is March 1 to May 10. Planting native trees and shrubs help to improve water quality, create wildlife habitat and can provide a source of income in the future. #### MARYLAND FARMER - COVID-19 RELIEF PROGRAM

MDA is accepting applications to help producers impacted by the pandemic. All contract poultry growers are eligible for a direct payment of \$1000 per poultry house (capped at 5 houses) and those whose flocks were depopulated during the pandemic are eligible for an additional \$1500 per house. Maryland farmers who received federal funding on the first round of Coronavirus Food Assistance Program (CFAP) are eligible for a 15% bonus payment.
